

General Release and Indemnity Agreement

I, \_\_\_\_\_ (printed name) intend to participate in fly-in events sponsored by the Recreational Aviation Foundation, also referred to as the (RAF), during the year 2017 at McIntosh Reserve Park in Carroll County, Georgia. I UNDERSTAND THAT SUCH EVENTS ARE IN NO WAY SPONSORED BY OR AFFILIATED WITH CARROLL COUNTY. I agree and understand that my participation at these events is taken solely at my own risk and expense. I further understand and agree that McIntosh Reserve Park does not possess an FAA approved landing/take-off site and that any landings/take-offs from the large, grassy field during the RAF event should be considered an unimproved and unsanctioned landing/take-off area. I further agree and understand that I am solely responsible for walking the landing/take-off area and making the determination for myself as to the safety of using said unimproved, grassy field for such purpose.

I also agree that neither Carroll County nor any of its employees, agents or elected officials have made any representations as to the safety of using aircraft or said grassy field at McIntosh Reserve Park as a landing/take-off area for any aircraft and any use of said field and aircraft is being undertaken at my own risk. I alone am responsible for determining whether any aircraft and said field is suitable.

I understand that participating in these activities is life-threatening and extremely dangerous. I acknowledge that severe bodily injury or death could occur from a multitude of sources related to these activities, including but not limited to: falling from a significant height, lack of breathable air, impact from plane parts falling on or touching me, excessive G forces, or other injurious sources. These injurious sources could result in many severe injuries including but not limited to: heart failure, stroke, increased blood pressure, puncture or impact wounds, inability to breath, complete paralysis, or death.

I understand that Carroll County makes no warranties, and I hereby and waive any and all implied warranties associated with these activities.

I further agree and understand that members/representatives of the Recreational Aviation Foundation may place cones, flags or other boundary or signaling devices at said field and that any reliance upon the same for safety is taken at my own risk and that neither Carroll County, nor any of its agents, employees, or elected officials is responsible or in any way affiliated with the same.

I HEREBY WAIVE AND RELEASE CARROLL COUNTY, ITS AGENTS, EMPLOYEES AND ELECTED OFFICIALS FROM ANY NEGLIGENCE RELATED TO DAMAGES OF ANY KIND, including but not limited to: failure to inspect, failure to act, failure to warn, failure to supervise, property damage, bodily injury, and death which is in any way related to my participation in the fly-in events scheduled during the year 2017 at McIntosh Reserve Park, including but not limited to the use of said aircraft and grassy field for landings/take-offs.
